Defending Your Pension and Health Insurance Benefits

President's Message Bill Funkhouser



n July 28th, I received a phone call from Larry Pfeiffer telling me that, for personal reasons, he was resigning from the position of IRTA Vice-President. Section 3. C. of the constitution says:"Should a vacancy occur in any office other than that of President. the President, with Executive Committee approval, shall appoint a replacement for the remainder of the term." So, I began thinking about members I thought would be a good choice for the position. I discussed several possibilities with Executive Director Jim Bachman. I then began calling people to see if they would be interested in the position. I went through 6 names from 3 different Areas of the state, and all turned down the position. Since the Constitution says the Vice-President shall be the Chair of the Constitution Committee and I was also appointing the Vice-President to Chair the Executive Director search committee. I felt it was very important to get the position filled quickly with a competent person. I contacted former President Roger Hampton, and he agreed to accept the position to move forward with these vital committees. Roger is very passionate about IRTA and concerned about keeping IRTA relevant in the future. I know he will do a great job. Thank you, Roger, for being willing to accept this responsibility.

What happened here emphasizes one of my greatest concerns about our association. That is the lack of new people stepping up to accept positions of leadership. Every 2 years we elect new officers and half of the Area Representatives. When I first became a member of IRTA and began attending conventions, the elections were a major part of the conventions with almost every office being contested at each convention. For the last several years, with few exceptions, there has only been one candidate for each position. One of the exceptions was in 2017 when John Flaherty and I were candidates for Vice-President. Beforehand we agreed that no matter who won, we felt the association would be in good hands and that the winner would be an old guy with a gray beard. As I told John then and many times since, I think competition is good for the association as it increases interest in the elections.

Next year at the convention, we will be electing the four officers and representatives for Areas 2, 4, and 6. Any member in good standing is eligible to run for any of these positions. All you must do is have someone turn in a nomination form for you. I think it would be great for our association if we have 2 or more candidates for each position. If you know someone you think would be good in one of the positions, talk to them and encourage them to get involved.

Again, thank you all for being members of the only organization whose sole purpose is protecting the benefits of retired educators.

IRTA Foundation Scholarships 2023

The 2023 application and current guidelines for the IRTA Foundation Scholarship is now available. Applications and current guidelines are posted on the IRTA website at www.irtaonline.org and located under the Foundation tab.

One **\$2,000** scholarship is available in each of the six **IRTA Areas** of the state. These scholarships are only available to incoming juniors or seniors in college enrolled in a certified teacher training program. The deadline to postmark or email applications is March 7, 2023.

Another scholarship available in 2023, is the Moler-Austin Scholarship which offers two \$4,500 scholarships to KENDALL COUNTY high school graduates that will be entering their Sophomore, Junior, or Senior year in college and with a declared major in Education.

Applications for any of the above scholarships must be postmarked or emailed and sent to the IRTA office on or before March 7, 2023, and the recipients will be announced by April 21, 2023. The awards will be given as follows: one half in June for the fall semester with the balance to be awarded in January upon registrar verification of a 3.0 or above GPA on a 4.0 scale.

people of Illinois disappointed with these results, don't give up hope. Tomorrow is a new day," said Leader Durkin.

• The Chicago Sun-Times reports that Rep.Tony McCombie (R-Savanna) has been tapped as the Republican party's upcoming House leader.

Illinois Democrats now control:

- A supermajority in the Illinois Senate: possibly 39 Dem 20 GOP, which is a net loss of -2 Democrats
- A supermajority in the Illinois House: possibly 77 Dem 41 GOP, which is a net gain of +4 Democrats

IRTAPAC ENDORSEMENTS FOR THE GENERAL ASSEMBLY

The Illinois Retired Teachers Association's (IRTA) most important objective is fighting for the rights of our members. We do this by working to elect legislators in Springfield that will keep the best interests of Illinois retired teachers in mind while voting on issues such as health insurance funding and pensions. These are just a few reasons why the Illinois Retired Teachers Association Political Action Committee (IRTAPAC) is so important during the election season.

The IRTAPAC developed a questionnaire used to evaluate candidates seeking endorsement in the November 2022 election. The questionnaire was mailed to all candidates on the ballot running for both the House and the Senate during the 2022 election (excluding write-ins). A total of 73 were returned from the House of Representatives (39-D & 34-R) and 36 (20-D & 16-R) from the Senate totaling 109 returns, which is historically the most returns that the IRTAPAC has received during an election cycle. The questionnaire contained questions regarding their position on matters such as the constitution, the current tax code, health insurance, Teachers Retirement Insurance Program (TRIP), and funding. The recipients to receive endorsement were carefully selected and voted on by the IRTAPAC Committee, then ultimately approved by the IRTAPAC Board of Directors.

The IRTAPAC conclusively made the decision to endorse 52 House candidates, and 27 Senate candidates for the 2022 Election Cycle. All 27 endorsed Senate candidates won, and for the House all but 2 candidates (Brian Meyers D-63 & Kevin Wallace R-49) won.

We are very pleased with the outcome of this election and are confident that each legislator we chose to endorse has our members best interest in mind. The IRTAPAC strives to support candidates who understand the importance of retired educators' pension and health insurance benefits.
