**HELEN KENNEDY SCHOLARSHIP**

1. GENERAL INFORMATION

- A. The scholarship will be awarded to one full-time student each academic year.
- B. The scholarship recipient shall receive a grant of \$1,000 each for fall and spring semesters, totaling \$2,000 for the year, to be used for educational expenses.
- C. If for any reason a recipient does not conform to any or all the policies, the IRTA Foundation Board has the right to revoke the scholarship.
- D. All applications must be postmarked and mailed or emailed to the office of the IRTA Foundation on or before March 7, 2024, prior to the applicant's sophomore, junior, or senior year in college. Recipients will be notified by April 21 of that same year.

2. ELIGIBILITY

- A. The student must be accepted into a Teacher Certification Program in order to receive IRTAF scholarship funding.
- B. Applicants must be a graduate of an Illinois high school. The recipient of the Helen Kennedy scholarship must submit proof of graduation from an Illinois high school before receiving funds.
- C. Applicants must have a declared major in education.
- D. Applicants must be enrolled in a recognized college or university.
- E. Applicants must have a 3.0 GPA or higher on a 4.0 scale.
- F. Applicants must provide official college/university transcripts prior to receiving funds.

3. APPLICATION PROCEDURE

- A. Each applicant must complete an application provided by the IRTA Foundation.
- B. Each applicant must submit a one page (double-spaced) personal letter of introduction, also stating reasons for applying and reasons why the applicant should be named a recipient.
- C. All official college/university transcripts must accompany the application.
- D. Proof of graduation from an Illinois high school must accompany the application.
- E. A signed "Consent to Release Information" form must be submitted with each application.
- F. Verification of acceptance in an accredited Teacher Education Program must be provided. (School of study on the official transcript is acceptable)
